



\$176 BN IN OVERAL DAMAGE Sectors & regions with highest damage


Significant damage has been sustained by the **social and infrastructure sectors**. Damage remains to be concentrated along the **frontline regions**, as well as in **Kyivska region**



TOTAL RECOVERY AND RECONSTRUCTION NEEDS (US\$ BILLION)






TOTAL RECOVERY AND RECONSTRUCTION NEEDS (US\$ BILLION)



2025 RECOVERY AND RECONSTRUCTION PRIORITIES Prioritization Approach

- PIM IN ACTION: For the first time, the Public Investment Management system was used to identify and prioritize RDNA4 2025 investment needs through the Single Project Pipeline
- WHOLE-OF-GOVERNMENT APPROACH: Ministries and agencies collaborated to identify, prioritize, and approve 2025 investment projects using a structured and transparent process
- STRONG COORDINATION: Development partners worked closely with the government to support the piloting of a structured approach to public investment, setting the stage for stronger, more strategic decisionmaking in the years ahead


FRAMEWORK FOR PUBLIC INVESTMENT MANAGEMENT AT THE CENTRAL LEVEL



2025 RECOVERY AND RECONSTRUCTION PRIORITIES Financing Needs, Secured Funding, and Gaps

- 2025 recovery and reconstruction needs
 - Total: **\$17.32 billion**
 - Investment projects: \$11.88 billion
 - Non-investment programs: \$5.44 billion
- Secured funding
 - Total: \$7.37 billion
 - Investment projects: \$5.46 billion
 - Non-investment programs: \$1.91 billion
- Financing gap
 - Total: \$9.95 billion
 - Investment projects: \$6.42 billion
 - Non-investment programs: \$3.53 billion


Investment projects

- Aligned with emerging **PIM system** introduced in 2024
- Single Project Pipeline with 787 projects:
 - **304** projects prioritized for 2025
 - 92 projects included in the capital budget
 - **16** projects funded via the recurrent budget
- Approved by the Strategic Investment Council, chaired by the Prime Minister

Non-investment programs

- Separate prioritization process
 - **44** programs prioritized for 2025
 - 19 funded through recurrent budget or development partners
- Includes housing compensation, demining, and social transfers
- Led by the Ministry for Development of Communities and Territories with line ministries' inputs
- Approved separately by the Cabinet of Ministers
